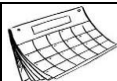

## Action Alert: Comment on Pipeline Stream Crossing Permit by 9/17

### WVDEP is proposing to change requirements for an important permit that regulates pipeline construction activities in streams and wetlands.

The WVDEP agreed to permit the construction of the Mountain Valley Pipeline and Atlantic Coast Pipeline through streams and wetlands according to a permit called the Nationwide 12 issued by the U.S. Army Corps of Engineers.

WV Rivers and our partners called into question the validity of this permit for the Mountain Valley Pipeline and the Atlantic Coast Pipeline when we discovered it was not in compliance with permit requirements established by WVDEP last year.

Now, rather than requiring massive pipeline projects to meet the stream and wetland crossing requirements in the Nationwide 12, **WVDEP is proposing to change the permit conditions.** The proposed modifications are now out for public comment through September 17. ## Election Odds and Ends

- According to the WV Secretary of State, there are thousands of attempts a week to hack into voting systems. WV's system is constantly monitored and none has succeeded. While West Virginians can register to vote online, none vote online. Voting equipment is not connected to the internet.
- Poll worker training is the responsibility of each County Clerk. The Secretary of State provides up-to-date materials, but does not control what is used and neither can control how much each poll worker absorbs, so mistakes (hopefully few) can occur. If you have or know of someone having a problem voting, and the problem can't be resolved at the polling place, do not hesitate to contact the County Clerk or the Secretary of State's office. Is the polling place accessible? Are voting devices positioned to assure privacy? Are voters at the wrong polling place directed to the right one? Provisional ballots offered as required?
- First fall campaign finance reports are not due until later this month, but if you want information about a PAC (328 PACs and Independent Expenditure Committees are registered in WV!) or a candidate's campaign finances (including who contributed), the primary election information is there and general election information will be available in the Elections Division on the Secretary of State's web site. Click on "Campaign Finance" and go exploring.
